## Terms & Conditions of Sale

**1. BIDDER REGISTRATION:** The auction is open to the public and all bidders are required to register with the auctioneer to receive a bidder's card. Bidder Registration will begin at 9:00 A.M. on Auction Day.

**2. PREVIEWS:** The assets will be available for previews two hours prior to the auction. All assets are offered and sold in As-Is condition without warranty. Bidders are encouraged to preview the items included in this auction.

**3. GENERAL TERMS:** These items are being sold pursuant to an Order of The United States Bankruptcy Court and will be sold to the highest bidder, individually or in bulk at the discretion of the Trustee and/or Auctioneer. The auction will be conducted in accordance with the Court Order granting in part Trustee's Motion for order authorizing sale by public auction of substantially the assets of the Debtor free and clear of liens, encumbrances and interests with liens, encumbrances and interests to attach to the proceeds of sale entered by the Honorable Raymond B. Ray, Judge, United States Bankruptcy Court. The auction is to be conducted on a cash basis without credit bidding.

**4. AUCTION FORMAT:** This auction is conducted By Order of The U.S. Bankruptcy Court in accordance with the terms and conditions set forth in the order of the Court. The assets will be offered in Bulk or By the Piece. These trucks & trailers are offered in As-Is condition.

**5. CURRENT STALKING HORSE**

**OFFER:** The Trustee currently has a stalking horse offer in hand for all (3) trucks and (4) trailers which will be used as the opening bid. The amount of the stalking horse offer is \$27,500.00 which includes a 10% Buyer's Premium. Increments in the advance of bids made at the auction will be at the discretion of the auctioneer.

**6. PAYMENT:** Payment in full is expected at the conclusion of the auction by Cash, Cashier's Checks or Money Orders. Corporate checks will be accepted when accompanied by a current Bank Letter (made specifically for this auction and addressed to National Auction Company) guaranteeing payment and subject to verification at the time of Bidder's registration. Bidders who leave the auction site without paying in full are required to make a deposit in the minimum amount of 25% and advise auction staff when they are returning with the balance due.

**7. FLORIDA SALES TAX:** All sales are subject to the rules of the Florida Department of Revenue. Florida dealers with resale numbers must bring a certificate to the auction which must be presented at the time final payment is made to the auctioneer. Sales tax due for vehicles is payable by purchaser (s) at the time of title transfer and registration.

**8. BUYER'S PREMIUM:** A 10% Buyer's Premium will be added to all top bids and included in the total purchase price.

**9. METHOD of SALE:**

a. The method and order of sale will

be at the auctioneer's discretion.

b. Recognition of bid increments will be at the discretion of the auctioneer. In the event items are offered and no bids are received, the auctioneer may remove them from the order of sale and offer it a later time during the auction or regroup them with other items. It is the intension of the Trustee to sell all assets of the Debtor.

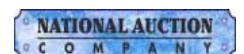
The auction will be audio or video taped to provide a record of the auction event.
